The Association of Chinese Political Studies will hold an international symposium on China's transition and ascension in conjunction with its 18th annual meeting at San Francisco State University in San Francisco, California in July 30-31, 2005. China's reform, open-up, and development over the last two decades have made enormous impact on the political, economic and cultural lives of the Chinese people as well as on the rest of the world. China's transition and ascension have become the two major themes in the field of China studies across all academic disciplines. We welcome all papers that address any aspect of the central theme and the main questions related to the broad theme, which could include domestic politics, economics, culture, society, military, foreign policy, foreign relations, Taiwan Strait relations, Hong Kong and Macau in transition, their origins and consequences, problems and challenges, domestic and global implications, continuity and change, and retrospective and prospects. We will consider all topics and all important issues of Chinese politics.

Paper proposals should include paper title, names of authors, institutional affiliation, address, phone number, fax number, e-mail address, and one-page abstract. The deadline for submission of paper proposals is December 15, 2004.

Journal of Chinese Political Science (JCPS) will be published by Kluwer Academic Publishers for the Association of Chinese Political Studies (ACPS), beginning 2005. Kluwer, located in Dordrecht, London, Boston, New York, annually publishes 650 academic journals and 1200 books. Kluwer publications have earned the esteem of scientists and professionals around the world.

JCPS is a refereed academic journal that publishes theoretical, policy, and empirical research articles, research notes, and review articles on contemporary Chinese politics across the whole spectrum of political science. However, JCPS also welcomes manuscripts on different aspects of contemporary China when these relate closely to Chinese politics, political economy, political culture, reform and opening, development, the military, law and

legal system, foreign relations, and other important issues of political significance.

JCPS articles are abstracted and indexed in OCLC PAIS International, International Political Science Abstracts, Historical Abstracts, America: History and Life, Sociological Abstracts, Social Services Abstracts, Worldwide Political Science Abstracts, and EBSCO Database.

The ACPS 17th Annual Meeting in 2004

The 17th annual meeting of the Association of Chinese Political Studies (ACPS) was successfully held between June 11-12, 2004 in Beijing in collaboration with Renmin University of China, the Carter Center, and other organizations. The broad theme of the conference is "Political Civilization and Political Modernization in China," which has become one of the most challenging topics in the field of China studies. The two-day conference brought together more than 250 scholars on China studies, among whom about 40 were from outside of China. There were 16 panels and about 100 papers presented. Participants explored a wide variety of topics related to the central theme, such as political civilization and reform in China, democratization and rule of law, development and change of NPC system, governance at grassroots, transition of ruling party and democracy within the party, local elections, NGOs and civil society in China, historical reflections on democratic politics in China, political analysis of governance at grassroots, theories and practices of constitutionalism, community construction and urban governance, international comparison of democratic transition, contemporary discourse of political philosophy, political concepts and political civilization, interaction across the Taiwan Straits, reform of political institutions, political culture and institutional change, institutional change and analy-

At the business meeting of the ACPS during the conference, the Association's Bylaws were adopted by vote of

the members present at the conference, which were aimed at making the organization more institutionalized and more professional. A new ACPS Board of Directors was elected by vote of the members present at the conference: Shiping Hua (president), Sujian Guo (president-elect), Baogang Guo, Christina Mao, Gregory Moore, Ka Zeng, and Baohui Zhang (in alphabetical order).
