# CALL FOR PAPER The 23rd ACPS Annual Meeting & International Symposium

## "China in Search of Sustainable Development, Social Harmony, and Soft Power"

## Endicott College, Beverly, Massachusetts Friday-Sunday, July 30-August 1, 2010

The Association of Chinese Political Studies will hold an international symposium at Endicott College, located in the historic Boston metro area, between July 30 and August 1, 2010, with a check-in date on Friday, July 30, and checkout date on Sunday, August 1. The conference is co-sponsored and hosted by Endicott College and will be held in conjunction with ACPS's 23rd annual meeting.

## **Conference Theme**

The conference's theme, "China in search of Sustainable Development, Social Harmony, and Soft Power," is broad enough to allow conference participants to address a number of key domestic and international issues, which can include, but is not limited to, the following areas:

- The reflection on the political development in the past three decades
- Theoretical and empirical investigations of current political development in China
- Theoretical or empirical studies of the new development model China is undertaking
- The role of civil society in China's transition
- Elite changes and local politics
- The causes and preventions of social disharmony in China
- The institutional building in modernizing China's political system
- The policy of "peaceful development" and China's relation with the world
- The détente and future direction of cross-Strait relations.



We invite research papers that address these issues as well as other important topics that are appropriate to the main theme of this conference. Well-researched conference papers will have the opportunity: (1) to be published in *Journal of Chinese Political Science* (JCPS); (2) and/or to be included in edited books.

#### Proposal and Paper Submission

All scholars and researchers who are working in related fields are invited to submit proposals for consideration. Please send your proposal(s) via email to meeting@acpsus.org no later than February 1, 2010. Paper proposals should include paper title, name(s) of author(s), institutional affiliation, title/position, mailing address, phone number, fax number, and e-mail address. All required information should be provided in MS Word format (not PDF) and sent as email attachments. Notification of acceptance will be issued no later than February 15, 2010.

Completed papers must be submitted online to the new ACPS website (http://www.acpsus.org) before July 15, 2010.



## CALL FOR PAPER5 "International Conference on Legitimacy and Governance" Fudan Institute for Advanced Study in Social Sciences Shanghai, China July 3-4, 2010

Fudan Institute for Advanced Study in Social Sciences (Fudan-IAS) at Fudan University is to call for papers for an international conference on legitimacy and governance to be held at Fudan University in Shanghai, China between July 3-4, 2010 (Saturday-Sunday), with check-in on Friday, July 2 and check-out on Monday, July 5. This conference will be co-sponsored by the Association of Chinese Political Studies (ACPS), Fudan University School of International and Public Affairs, *Fudan Journal of the Humanities and Social Sciences*, and *China Social Science Quarterly*.

## The conference theme

The theme of the conference is centered around "Legitimacy and Governance," aims to bring together a broad crossdiscipline of social science scholars to discuss the following related topics (not to exclude other related topics):

- General theories of legitimacy and critical reflections on theoretical development of legitimacy
- Cultural origins, intellectual development, and value judgments of the Western and Chinese theories of legitimacy
- Comparative studies of legitimacy theories and practices in China and the West
- General theories of governance and critical reflections on theoretical development of governance
- Comparative studies of governance theories and practices in China and the West
- Relations between values and practices with regards to legitimacy, governance, development, efficiency, justice, equality, freedom and order
- Theoretical reflections on the political legitimacy and effective governance
- The state of research on legitimacy and governance in Chinese local and grassroots organizations
- Civil society and governance
- The influence of globalization on the theories and practices of legitimacy and governance
- Green revolution, global governance, and new world order
- Global warming and environmental governance
- International relations theories and global governance
- Soft power and legitimacy
- Soft power and good governance

All overseas scholars and researchers who are working in related fields are invited to submit proposals for consideration. Please send your proposal no later than February 1, 2010 to Dr. Sujian Guo at <u>sguo@sfsu.edu</u> and please put "2010 Fudan-IAS conference paper proposal" in the subject line of your email. Paper proposals should include paper title, name(s) of author(s), institutional affiliation, title/position, mailing address, phone number, fax number, e-mail address, and an abstract of 250-300 words. All requisite information should be contained in a Word document (please do not use PDF) attached to your email. After the paper proposal review is completed by a conference organizing committee, the acceptance/rejection notifications will be sent to you no later than February 30, 2010. # <u>Conference</u> <u>Report</u>

## Two ACPS Panels at the 2009 APSA Annual Meeting Toronto, Ontario, Canada, September 3-6, 2009

This year, thanks to the efforts of former ACPS Research Director Jean-Marc F. Blanchard, the Association for Chinese Political Studies had the opportunity to sponsor two panels at the APSA Annual Meeting in Toronto.

The two panels were:

Panel 1: China, the United States, and Global Order (Chaired by Brantly Womack, University of Virginia)

and **Panel 2:** Globalization and the Chinese Regulatory State (Chaired by Dali L. Yang University of Chicago). Further details on these panels can be found at the APSA website.

Attendance at this year's APSA panels appeared to be down considerably from previous years, most likely because of the impact of the global economic crisis on college budgets. One of our discussants could not join us because his institution would not pay for his trip. However, based on the anecdotal information I have (and comments from a number of participants), our two panels were well attended, especially in comparison to other China-related panels in Toronto. Hopefully this attendance will be reflected in the allocation of panels for the coming year.

## **ACPS Doctoral Student Best Paper Prize**

After thorough consideration, the evaluation committee for the "ACPS Doctoral Student Best Paper Prize" recommended that the 2009 Prize be given to Li Xiaojun, a third-year PhD student in the Political Science Program at Stanford University, for his paper "Social Rewards and Socialization Effects in the International Institutions" which was presented at the ACPS-NCCU conference in Taipei.

The evaluation committee remarked that Li's well-written and methodologically sophisticated "Social Rewards and Socialization Effects in International Institutions" paper makes a serious contribution to the field. While most studies on IGOs provide important insights about how state participation in specific IGOs can influence the relationships among states (i.e. international socialization), they fail to exploit quantitative techniques to address China's participation in a large number of IGOs over time and the possible socializing effects of such IGOs on China. In the committee's view, Li rectifies this gap. His paper provides a clear theory, thoughtfully conceptualizes and operationalizes variables, and advances a number of testable hypothesis. Furthermore, Li makes creative use of social network analysis techniques. Finally, he provides a good justification for using the Event History Model to analyze the data and test the hypothesis. His conclusions are well supported and convincing.

## **Recent Publications by ACPS Members**

**Toward Better Governance in China: An Unconventional Pathway of Political Reform** Edited by Baogang Guo and Dennis V. Hickey

Toward Better Governance in China takes a fresh look at the latest efforts made by Chinese leaders to promote governance-based reform. It asserts that the improvement of governance has now become one of the breakthrough points of the much anticipated political reform. One of the advantages in placing the improvement of governance first is that it is less risky than embarking upon a full-scaled electoral reform. Electoral democracy is undoubtedly an important element in a functional democracy. But equally important is the effectiveness, transparency, accountability, and openness of the governing process. Better governance implies greater transparency, open deliberation and participation, and less adversarial political confrontation and conflict. If constructed properly, China may become the sort of democratic administration or administrative democracy that Robert Dahl discussed in 1947. Clearly, political reform of this kind does not follow the conventional wisdom of a democratic transition



which places heavy emphasis on electoral reform or the precedence of the electoral reform to the government reform. This book is intended to shed some new light on the ongoing debate about the direction of China's political development.

## Greater China in an Era of Globalization

Edited by Sujian Guo and Baogang Guo

China's growth in the past few decades has been unprecedented, and continues to stay strong as it expands its influence around the globe. However, in many ways, the once insular China is still looking to find its footing as an international player in the globalization game. *Greater China in an Era of Globalization* looks at the success of China and its surrounding territories of Taiwan, Hong Kong, and Macau and asks the question "What is Chinese globalization?". The contributors in this volume look to answer this question by examining China's role both in its immediate sphere of influence and in the greater world. In doing so, the contributors argue that its push to globalize has had as much effect on the country itself, both politically and culturally, as it has had on the world. The contributors further the argument by analyzing China's influence on the rising nations in Africa and Latin America, before ending the book with a comparative analysis between it and the historic rise and fall of influence of its European counterparts.
