On June 10-11, 2017, the ACPS and the Zhou Enlai School of Government of Nankai University hosted ACPS's 30th annual meeting and international symposium in Tianjin, China. The conference theme was "China's Public Policy and National Governance." Attended by 79 scholars from 12 countries and regions, the conference was a huge success! JCPS Editors-in-Chief Report on Status of the Journal and Call for Citations

ACPS Members, contributing authors, and colleagues:

The editors of the Journal of Chinese Political Science (JCPS) are proud to announce that the journal has recently has been accepted into ESCI, Thomson Reuter's Emerging Sources Citation Index, a new index in the Web of Science Core Collection. We have recorded an increasing number of article views and downloads, especially for our special issues and new "review essay" format.

We are also currently under review to have our journal listed as a SSCI journal, and hope to have this distinction in the near future. When this listing happens, it appears

that our impact factor will be around 1 (citeScore = 0.96, SJR = 1.023, SNIP = 1.417).

Despite these recent achievements, the editors recognize that we still have work to do to improve the quality of the journal, and to ensure that our citation and download rates continue to increase (thus increasing our impact factor once listed with SSCI). Therefore, we want to reach out to our community to request your continued support.

We encourage you to cite the articles published in our journal in your publication in other journals, and also to communicate any suggestions you might have to improve the journal to the editors. Please also sign up for each new table of contents to be automatically sent to your inbox, and remember to add citations to relevant articles published in JCPS. We will also have a new social media presence that will allow you to stay updated with both JCPS and ACPS events and news, which we will announce shortly.

As our journal is still under review to determine its

impact factor when listed in the SSCI, we hope that you and your colleagues will cite articles published in JCPS in your publications. The journal is important for our community to share and deliberate on our research findings, and especially for our junior colleagues' career development. Thus, we are grateful for your continued support for the success of JCPS during this pivotal time.

Special Report on the 30th ACPS Annual Meeting Jointly Held with Nankai University, Tianjin, China

Tianjin China, the site of the 30th annual ACPS meeting and international symposium, holds historical significance in China's interactions with the outside world. During the events of the Second Opium War (1856-1860), the Qing dynasty signed the Tianjin treaties, one of the infamous "Unequal Treaties," which gave concessions to six European countries, the US, and Japan to set up permanent trade access to Tianjin's port, churches and residences around the city, as well as diplomatic consulates in Beijing. For the first time in its history China was open to the world, and the world

has never been the same since. Tianjin remains important today as the port city for Beijing, China's capital, and the third largest city in China.

On June 10-11 the ACPS and the Zhou Enlai School of Government of Nankai University hosted ACPS's 30th annual meeting and international symposium at Nankai University's Jinnan Campus. The conference theme was "China's Public Policy and National Governance."

The conference was attended by 79 participants from many different institutions across 12 countries and regions, including the U.S., China, Canada, Australia, New Zealand, Mexico, Germany, Singapore, Scotland, South Korea, and United Arab Emirates. Presentations were given by academics, doctoral candidates, and researchers associated with international organizations, research centers, and universities.

International relations-focused papers comprised of such topics as Chinese Economic Diplomacy and International Aid; Regional Security; South China Sea Disputes; Deployment of the Terminal High Altitude Air Defense System (THAAD) in South Korea; The One Belt One Road initiative (OBOR);

The Asian Infrastructure and Investment Bank (AIIB); and China-Europe relations. Domestic politics-oriented presentations included Internet, Media, and Civil Society; National and Local Governance Challenges; Environmental Governance; Political Culture; Values, Norms, and Political Trust; and Policy Innovation and Implementation.

The June 10 opening ceremony was facilitated by Nankai University Zhou Enlai School of Government's Dean Zhicheng Wu. Opening remarks for the conference were given by Nankai president Ke Gong, ACPS president Yi Edward Yang, and Wong Center for the Study of

Multinational Corporations executive director Jean-Marc Blanchard. Keynote speeches were delivered by Pierre Landry of NYU Shanghai, who went into some detail about the interesting roots of American scholarship in Chinese politics, Amitav Acharya of American University and former president of the International Studies Association (ISA), who addressed the imminent reality of a rising China, and Nankai vice president Guanglei Zhu, who reviewed recent reforms in central-local policymaking in China. The range of conversational focus and backgrounds between the speakers set the tone for what would transpire as an illuminating, collaborative, and multifaceted event.







Ghulam Ali has moved from Dept. of South Asian Studies, Peking University, Beijing to Dept. of Political Science, School of Marxism, Sichuan University of Science and Engineering, Zigong, Chengdu, China. He has also received national talent award (China) to conduct research on China-Pakistan Economic Corridor, China-South Asia Relations, etc. Ali's book *China-Pakistan Relations: A Historical Analysis* (2017) has been translated into Chinese and its Chinese version will be published early 2018 in China.

Jean-Marc F. Blanchard, Distinguished Professor with the School of Advanced International and Area Studies at East China Normal Univ. (Shanghai), continues to serve as Executive Director of the Mr. & Mrs. S.H. Wong Center for the Study of Multinational

Corporations (USA), a think tank focused on the politico-economy of foreign direct investment/multinational corporations in and from East Asia. In 2017, he co-edited a special issue of *Geopolitics* (22, No. 2) entitled "The Geopolitics of China's Maritime Silk Road Initiative." In the spring, he gave speeches at Stanford Univ. (US), the 4th Annual Shanghai Maritime Forum (China), and the 2017 Government Affairs Forum (Beijing, China). In the fall, he gave speeches at the 10th Baltic Sea Region Forum (Finland), the National Univ. of Singapore (Singapore), and Nanyang Technological Univ. (Singapore).

Zhiqun Zhu serves now as Professor and Chair of International Relations Department at Bucknell University.

Sheri Zhang Leimbigler, Professor of Asian Studies in the Dept. of Modern Languages and Literatures, Univ. of Ottawa, Canada and Jianfu Ma, Professor of Cultural Anthropology at North Minzu Univ., Ningxia, China jointly launched a research project titled "A Companion to Modern Chinese Culture and Literature: A Glimpse of the Beautiful Unseen and Untold Story of the Silk Road."
